





For the first time, electric vehicles became cobalt's largest end use sector


Electric vehicles (EVs) were the largest end use sector in 2021 and have the most growth potential.




Cobalt-containing battery chemistries accounted for 74% of the global electric vehicle battery market

Other market trends in 2021


China provided 71% of global refined supply growth It is also the largest cobalt refiner — 72% of total primary production, 104 kt in 2021.

Indonesia is the largest growth market for refined cobalt production after China.

It is expected to provide $\ensuremath{\ensuremath{\%}}$ of total refined and 32% of refined chemical growth.

Supply chain bottlenecks create disconnection between the DRC's production and exports to China in 2021.

Cobalt metal prices doubled in 2021 \$16/lb — January —> \$32/lb — December
